The regular meeting of the Planning Board was called to order by Chair, Bill Bruce. Harry Balz made a motion to accept the minutes as printed, 2nd by Bill Bruce. All Ayes

Bill Bruce welcomed new member Matt Simpson.

NEW BUSINESS:

File # 2010-30 BL Tax Map 88.11-1-11 Mary Delaney and Town of Horicon seeking a boundary line adjustment of parcels. Lengthy discussion ensued regarding the Boundary Line Adjustment regulations. Town Board Member Bob Olson stated that he recalls the board discussing the purchase of part of an adjoining lot. Harry Balz stated that the regulations state that the board has the discretion to determine whether an application constitutes a boundary line adjustment. Harry made a motion to waive the public hearing, 2nd by Georgia McMeekin, All Ayes. Harry made a motion to approve the Boundary Line Adjustment as this board has classified this as a boundary line adjustment as classifying this as a subdivision would create a non-conforming lot as there is no road frontage associated with the transfer and this will be merged with the Town owned property, 2nd by Georgia McMeekin. File # 2010-26 CU Tax Map 106 -1 15 Gerald Rickert seeking a Conditional Use to construct a 24' x 30' home with an attached garage and a 16' x 24' detached garage on parcel located at 48 Padanarum Spur in the LC -42.6 acre zone. Bill Bruce stated that there is was no public comment on this project. Harry Balz stated that this conditional use is necessary due to the parcel being in the 42.6 acre zone.
