Proposed Zoning Changes- ZO Gary McMeekin explained the proposed changes as far as the wording, and elimination of the section on multiple access docks associated with subdivisions. Councilman Olson opposes any changes until the whole thing is reviewed by the Planning Board, and reviewed with the Master Plan. Supervisor Bentley asked if the Planning Board had been asked to review and Mr. McMeekin said

no. Councilman Dooris asked why this wording was originally included as it appears to be "redundant"? Councilman Olson said it was put in "because previous Boards decisions were not honored, that is why it was put in". Counselor Schachner said signs and docks are not automatically affected as they are "temporary by nature". Councilman Dooris said if this was going to be enacted they should have done an actual dock inventory before it was put into effect". Supervisor Bentley said this proposed amendment just applies to multiple access docks and "nothing we have on record is covered by grand- fathering. ZO McMeekin said this original wording is confusing and does not cover anything we have now. We are trying to simplify by doing these changes. Councilman Olson said this issue is before the Zoning Board of Appeals. ZO McMeekin said "no, it is not". Councilman Olson said our process does not include the Zoning Officer making decisions himself. Councilman Dooris made a MOTION to send this proposed amendment to the Planning Board for their recommendation and have them report to the Town Board, Councilman Higgins seconded, all ayes. The Town Board will address this issue again once the Planning Board has given their opinion.

Mr. Balz said Joe Metzger gave the Town a very good price and saved the Town at least \$50,000.00, and that should be considered in this situation. Councilman Dooris said it is not an expense that should be billed to the taxpayers.

WHEREAS, the Town of Horicon, like all other local municipalities, strives to provide services to Town residents in the most beneficial and economically efficient manner possible with ever increasing budget constraints, AND

WHEREAS, the Town operates a Transfer Station, AND

WHEREAS, there has previously been a position of Full-Time Landfill operator at the Town Transfer Station, AND

WHEREAS, the Town Board has come to realize that the Town Transfer Station can be operated efficiently as is necessary for the benefit of Town residents without a Full-Time Landfill Operator, AND

WHEREAS, the Town of Horicon 2009 Budget does not include funding for the Transfer Station Full-Time Landfill Operator position, NOW, THEREFORE, BE IT

RESOLVED, that the Full-Time Landfill Operator position at the Town Transfer Station is hereby eliminated, AND BE IT FURTHER

RESOLVED, that the Town Supervisor is hereby authorized to take any steps necessary to effectuate this Resolution.
